#### **Deis Cothroime**

#### Fiontar agus luaíocht

Spreagann Ógra Fhine Gael tionsnamh, nualaíocht, infheistíocht agus féin-mhuinín. Creideann an pairtí go bhfuil sé tabhacht an rathúnas a chóthú, a roinnt agus a mhéadú. Seasimid d'eacamaíocht atá láidir agus iomaíoch. Creidimid gur ceart polasaí an rialtais, spreagadh a thabhairt do tionscnamh, agus luaíocht a thabhairt d'obair chrua, de thoradh ag tiomaint gníomhaíocht gheilleagrach agus ag cruthú post nua.

#### Sábháilteacht

Tá Ógra Fhine Gael ag iarraidh sochaí shábháilte a chruthú in Éirinn trína cuid saoránach a chosaint agus tríd an dlí a chur i bhfeidhm. Tuigeann an páirtí, freisin, tábhacht teaghlaigh i ngach cruth nuaaimseartha a neartú agus comhphobal a chothú. Seasann Ógra Fhine Gael don dlí agus an tsíocháin. Creidimid i bpionós níos láidre do coireanna agus níos mó gardaí a chur ar na sráideanna, ag an am céanna ag dul i ngleic le príomhchúiseanna cóiriúlachta mar aon le bochtaineacht agus míbhuntáiste oideachais.

#### Macántacht

Creideann Ógra Fhine Gael go gcaithfimid a bheith ionraic agus misniúil i ngach gnó agus go gcaithfimid cearta agus freagrachtaí na ndaoine a chothú. Seasimid d'ionracas an tsaoil phoiblí. Creidimid go gcaithfidh gach duine a dhulgais a dhéanamh chomh maith le taithneamh a bhaint as ár gcearta mar mhná agus fir na hÉireann.

#### **Uaillmhian**

Tá Ógra Fhine Gael ag iarraidh Éire uailleach a chruthú. Ba mhaith linn é seo a dhéanamh trí thionscnamh a dhéanamh ar iomhá do thodhchaí na hÉireann atá muiníneach sa bhaile agus thar lear. Seasimid do shaol dóchasach. Chun é seo a dhéanamh creidimid go gcaithfimid cáil idirnáisiúnta na hÉireann a chothú trí thacaíocht a thabhairt don Aontas Eorpach, agus cosaint a thabhairt do comhphobailtrí forbairtréigiúnach agus trí thodchaí ár bpáistí a choiméad trí aire a thabhairt don timpeallacht.

# Standing Orders for the 33<sup>rd</sup> Young Fine Gael National Conference

# Part 1 – Interpretation (for the purposes of these Standing Orders)

"Amendments to the Young Fine Gael Constitution and Rules" means the amendments to the Young Fine Gael Constitution and Rules proposed by certain Units or Organs of the Organisation and detailed in the National Conference Clár.

'Conference Motions' means the policy motions proposed by certain Units or Organs of the Organisation, selected for debate by the National Conference Steering Committee and detailed in the National Conference Clár.

'Conference Resolutions' means the resolutions proposed by certain Units or Organs of the Organisation, selected for discussion by the National Conference Steering Committee and detailed in the National Conference Clár.

**'Chairperson'** means the individual presiding at a Session.

'Delegate Card' means a card issued by the National Conference Steering Committee to a Registered Delegate upon arrival at the 33rd YFG National Conference.

'Emergency Motion' means any motion other than a Conference Motion or an Amendment to the Young Fine Gael Constitution and Rules and not appearing on the National Conference Clár, as prescribed in Part 10 of these Standing Orders.

'National Conference' means the 33rd National Conference of Young Fine Gael, taking place in the Glenroyal Hotel, Maynooth, Co. Kildare. 'National Conference Clár' means the programme/agenda for the National Conference.

'National Conference Registration Desk' is the registration desk where members register their attendance at the National Conference and are issued a National Conference Programme, a Delegate Card and miscellaneous items. This desk will open two hours before the commencement of the National Conference and will close at 15:30 on Saturday 22nd February 2025.

'National Conference Steering Committee' means those individuals appointed under Article 7 of the Young Fine Gael Constitution and Rules to organise the National Conference and who have not otherwise resigned.

*'National Executive'* means the current Young Fine Gael National Executive.

'National Executive Elections' means the elections of the President of Young Fine Gael, the Vice-Presidents of Young Fine Gael and the ordinary members of the National Executive as outlined in Article 6 of the Young Fine Gael Constitution and Rules.

'Observer' means a member of Young Fine Gael who is not a Registered Delegate, or any other person in attendance at the National Conference as an invited quest.

'Organiser Card' means a card issued by the National Conference Steering Committee to members of the Steering Committee and other persons assisting in the organisation of the Conference, as they deem appropriate.

'Photographic Identification' means

a current photographic student card, Garda ID, Passport, drivers' licence or other form of photographic identification permitted for use by the National Conference Steering Committee.

'Quorum' means 15% of the total number of Registered Delegates.

'Registered Delegate' means a member of Young Fine Gael who has attained membership on or before 31st October 2024 as per Article 6.4 of the Young Fine Gael Constitution and Rules; and who appears on the Register of Members; and who has registered their attendance via the National Conference Online-Registration Form before 3PM on Saturday 22nd February 2025; and who has been issued with a Delegate Card

'Returning Officer' means the General Secretary of Fine Gael or his nominee.

'Session' means the National Conference meeting either in plenary session, or in break-out meetings as outlined in the National Conference Clár, each of which shall be considered to be a "Session".

'The Great Debate' means the team debating competition being held on Friday 21st February 2025 at the 33rd National Conference.

'Unit(s) and Organs of the
Organisation' has the meaning
prescribed under Article 2 of the
Young Fine Gael National Constitution
and Rules.

'Young Fine Gael Constitution and Rules' refers to the constitution and rules of Young Fine Gael as adopted by the 32nd National Conference of



Young Fine Gael.

## Part 2 - Admission to the National Conference

A Delegate card, Observer card, Media card, Candidate card or Organiser card must be produced to gain access to any Session of the 33rd Young Fine Gael Conference at the Glenroyal Hotel, Maynooth, Co. Kildare.

#### Part 3 – Ultimate determination

The ruling of the Chairperson of any Session shall be final on all matters...

#### Part 4 - Referral

The Chairperson may adjourn a Session in order to consult with the National Conference Steering Committee on any matter relating to the National Conference.

#### Part 5 – Conference Motions and Amendments to the Young Fine Gael Constitution and Rules

- a) Other than in the case of Emergency Motions as provided for under Part 10 below, only Conference Motions and Amendments to the Young Fine Gael Constitution and Rules which are listed in the National Conference Clár may be moved.
- b) A Conference Motion or an Amendment to the Young Fine Gael Constitution and Rules may only be moved by the Unit or Organ of the Organisation listed on the National Conference Clár.

#### Part 6 - Quorum at Sessions

- a) Where fewer than 15% of Registered Delegates are present, a Session shall be deemed to be inquorate and the Chairperson shall adjourn that Session until they deem that Session to be quorate.
- b) Any Registered Delegate may call a quorum count.
- c) Only one quorum count may be called at each Session.

## Part 7 – Speakers and Registered Delegates

- a) At all Sessions, and at the Great Debate, speakers shall only be allowed speak for the duration announced by the Chairperson.
- b) Speakers must wear their respective card, as received from the National Conference Registration Desk, in order to be granted speaking rights.

#### Part 8 - Amendments

- a) Amendments to Conference
  Motions may be submitted
  to the Steering Committee in
  writing before 21:00 on Friday,
  22nd February 2025 and must
  be supported by no less than
  two Registered Delegates. Such
  amendments may be put to the
  floor at the Session subject to the
  absolute discretion of the National
  Conference Steering Committee.
- b) Emergency Motions and Amendments to the Young Fine Gael Constitution and Rules may not be further amended pursuant to this part.

#### Part 9 - Relevancy/Disruption

- a) If any Registered Delegate or any other person is directed to cease speaking on the grounds of irrelevancy, disruption or being in excess of the allotted time, that Registered Delegate or person must do so forthwith.
- b) In any event where a Registered Delegate or any other person refuses to cease speaking in line with subsection (a) of this Part, the Chairperson or a member of the National Conference Steering Committee may request that Registered Delegate or any other person to immediately withdraw from the Session.

#### Part 10 - Emergency Motions

a) Emergency Motions may be

- submitted to the National Steering Committee and may be put to the floor at any Session subject to the absolute discretion of the National Steering Committee.
- b) An Emergency Motion must be submitted in writing to the National Conference Steering Committee before 10:00 on Saturday, 22nd February 2025 and must be supported by no fewer than eight Registered Delegates.
- c) Emergency Motions must only deal with events of exceptional significance.
- d) All decisions of the National Conference Steering Committee in respect of this Part shall be final.

#### Part 11 - Voting

#### (A) Sessions

- The Chairperson of a Sessionshall appoint tellers for the duration of that Session.
- (ii) Voting at any Session shall beby a show of Delegate Cards.
- (iii) Conference Motions
  (or Resolution or any
  amendments there to),
  Emergency Motions and
  Amendments to the Young
  Fine Gael Constitution and
  Rules shall be put to a vote
  when, in the view of the
  Chairperson, they have been
  fully discussed.
- (iv) In the event that anamendment to a ConferenceMotion or Resolution isproposed, the followingprocedure shall apply:
  - Firstly, the Session must vote on accepting the amendment.
  - If the amendment is passed, the Conference Motion as amended shall be put to the Session.



- If there is more than one amendment proposed, the Chairperson shall call for a vote on the amendments, which in their opinion are the most far reaching first.
- (v) A Conference Motion or Resolution (or emergency motion or any amendment there to) will be deemed to have been carried when the total number of Registered Delegates voting in favour of the motion exceeds the total number voting against the motion.
- (vi) Amendments to the Young Fine Gael Constitution and Rules will be deemed to have been carried when they achieve a two-thirds majority of the total number of Registered Delegates voting in Favour or Against, in accordance with Article 12.1 of the Young Fine Gael Constitution and Rules. For the avoidance of doubt, Registered Delegates who abstain from voting shall not be counted as having voted when calculating the result of a vote on each Amendment. .
- (vii) The Chairperson may order a re-vote where the outcome of a vote is unclear by a show of Delegate Cards.

- (viii) If the Chairperson orders a revote pursuant to subsection (vii) of this part, then the tellers will count the votes and inform the Chairperson of the result of the vote.
- (ix) In the event of a tie,
  a Conference Motion
  or Resolution (or any
  amendments thereto or an
  Emergency Motion) shall
  be deemed not to have
  beencarried, as a majority has
  notbeen attained.
- (x) Once a vote has been calledand ruled by the
   Chairperson, and a result declared, no further requests for counts shallbe considered.

#### B) Voting at National Executive Elections

- (i) All Registered Delegates will be entitled to vote at the National Executive Elections.
- (ii) The National Executive
  Elections will be run in
  accordance with the
  procedures outlined by the
  National Executive Steering
  Committee.
- (iii) A Registered Delegates will not receive a ballot paper for the National Executive Elections unless Photographic Identification is produced to

- authenticate their identity.
- (iv) These procedures, and the counting of votes in the
   National Executive Elections, shall be overseen at all times by the Returning Officer.
- (v) All matters pertaining to the National Executive Elections, including appeals, will be dealt with through the Returning Officer and not the National Conference Steering Committee.
- (vi) The ruling of the Returning Officer shall be final in all matters.

#### Part 12 – Standing Orders

Once these Standing Orders have been accepted by the National Conference, they shall not be suspended or amended.

# Mairéad McGuinness

#### **Guest of Honour at the Shane McEntee Memorial Dinner**

Mairead McGuinness is a former European Commissioner for financial services, financial stability and Capital Markets Union (2020-2024).

Before joining the Commission, Mairéad was First Vice-President of the European Parliament from 2017. She served as a Fine Gael MEP for 16 years and was a Vice-President of the Parliament since 2014.

As Vice-President, she oversaw relations with national Parliaments, led the Parliament's dialogue with religious and philosophical organisations and had responsibility for the Parliament's communication policy.

During her time in the Parliament, Ms. McGuinness sat on a range of committees, covering agriculture, environment, public health, budgets, petitions and constitutional affairs. Her legislative work included leading for the EPP Group on the European Climate Law, the revision of medical devices legislation, and CAP reform post-2013. As an Irish MEP representing the border region, she was outspoken on Brexit and the consequences for the EU and Ireland.

In 2006-2007, Ms. McGuinness chaired the Parliament's investigation into the collapse of the Equitable Life assurance company which identified issues around weak financial regulation.

Prior to becoming an MEP, she was an award-winning journalist, broadcaster and commentator.



# National Executive Report 2024

#### **Dublin by Jamie Malone**

Since taking over my role as Dublin Regional Organiser, the region has been incredibly active over the past 2 years, with our college branches continuing to strengthen, local branches becoming much more active than they had previously been, and a phenomenal effort put in across the region over the Local, European, and General Elections. My aims for Dublin for my term were to drive recruitment, local branch rejuvenation, hold regional events, and support election campaigns.

When the term began, the branches got off to a flying start with almost every branch holding an AGM in the first 2 months, setting the foundations for the coming year's busy election period. We also had our first national campaign day in Dublin for Cllr Frank McNamara, with another National Campaign Day for Cllr David McManus, as well as many Regional Campaign Days across the local campaign. Our local branches were at the forefront of YFG's contribution to the Local Election Campaign with local canvass and leaflet drop days held across the region regularly by branches. I'd like to thank everyone for their phenomenal efforts which saw us help to elect YFG Councillors in the Dublin Fingal, West, Central, Bay North, South West, Dún Laoghaire and Rathdown constituencies.

As well as helping to support our local election candidates, the Dublin local branches held many other great events over the term including many social nights, community cleanups, fundraisers, guest speaker events, Dáil trips, and much more. We have seen such a great increase in local activity that sets branches up well to continue growing under the tenure of the incoming Regional Organiser. One of our best local branch successes has been the establishment of the Dublin North West YFG branch which hadn't been able to affiliate for many years. I'd like to thank the members there for their dedication to setting the branch up again and look forward to seeing it grow further in the coming years.

Our college branches in Dublin have seen some phenomenal increases in membership over the last 2 years, with college branch membership more than doubling over the past 2 years! Our YFG branches engaged with society life on campus by getting involved in debates and Mock Dáil events and represented YFG strongly with some great wins at these debates. Our college branches also collaborated and met together for some social nights, which presents a great opportunity for incoming committees to collaborate more after the busy years we've had campaigning across the county & city.

With the help of the Dublin Regional Council (DRC), I have worked hard over the last 2 years to support our branches, to organise regional events and to streamline communications in Dublin so that members across the region were aware of all YFG's activity. Our first Dublin Day saw members discuss Budget 2024 with Barry Ward TD in Trinity, with a pub quiz and social night afterwards. The next year's Dublin Day came back bigger and better with a leaflet drop for James Geoghegan TD, followed by a debating competition in the Mansion House as well as a tour by our host the Lord Mayor, rounding off the night with karaoke and pizza. As well as our regional event days, we held many regional campaign days for the local and general elections in almost every constituency during the campaign, with members across Dublin making a phenomenal effort to support our contribution to the campaigns. I'd like to thank the outgoing members of the DRC; Alex, Bill, Isabelle, James, Oisín, Sai, Shane, and Wim for their efforts over the past 2 years.

The past 2 years have seen the Dublin region continue to strengthen with many of our local branches rejuvenated, great increases in membership across local and college branches, and great levels of activity particularly around the election campaigns. I look forward to seeing the region continue to grow under the next Regional Organiser.

#### **Leinster by Rachel Kerley**

I was delighted to be asked to take over the responsibilities for Leinster Regional Organiser in September 2024, following the previously LRO resignation.

As the first task I reached out to Branch Chairs in Leinster to gather how the branches were from their perspectives and advising I would be the new point of contact for Leinster.

We held an AGM for the Leinster Regional Council which appointed a new Chair & Secretary. With the timing of September, most individuals were very much involved in election teams, with the expectation of forthcoming General Election. Preparation focused greatly on General Election, vision was put onto how Leinster could assist with



candidates and the wider party. Two regional days were held in Kildare & Carlow during the election period.

Leinster has had successful growth in the term of this executive and this was evident since taking over the role as LRO. Members worked exceptionally hard for the Local, European and General Election and credit should be recognised to all. The region has great potential to continue to grow.

#### Munster by Liam O'Donovan

The Blue-Weekend made a comeback to Munster in 2023. A highlight in the calendar year for Young Fine Gael members who gathered Macroom the night before Beal Na Blath for a get together involving chats, quizzes and songs.

A branch has been opened in Co. Waterford expanding the footprint Young Fine Gael has in Munster. In county Cork the Cork Sub-Committee was disbanded to create constituency branches within the county. This posed on-going challenges for branches to meet quorum at meetings, but it was a step that saw new members joining the organisation. Branches in Clare, Kerry and Tipperary continue to function well and worked closely with their senior party counterparts. Limerick is an area the next Munster Regional Organiser and National Executive may wish to target for rejuvenation.

The Munster Regional Council worked well together but a demand for more meetings is prevalent now that the year of the elections, 2024, is over which took the majority of time for all Young Fine Gael members across the country.

In all Munster has seen some gains during this National Executive despite challenges but further progress is needed to yield the full potential of this region. The upcoming membership affiliations period will be of utmost importance.

#### **North West Report by Sean Martyn**

To say that the last two years have been eventful would be an understatement, since February 2023, I've been across the North West region meeting members for various events, canvasses and in the case of Cavan Monaghan's Billy Fox branch, the odd charity mountain climb. In this period not only have we seen an increase in activity but also in membership through increased recruitment and higher levels of membership retention. On other occasions members from across the country ran our YFG stand and engaged with delegates who wanted to learn more about us and our plans, polices and campaigns

The previous evening saw a great YFG turnout at our Pre Ard Fheis Social in Claregalway. As a precursor to the following days events, members were given an opportunity to unwind with our county colours night in the Claregalway Hotel. We started with our bilingual Tráth na gCeist, where some of our current exec members were so kind as to provide their baby photos to be pored over by the membership. Congratulations to our winners on the night of Jamie Malone, Bébhinn Lombard, Daniel Lynch and Liam Coppinger, who each received a pot of honey and a bag of turf. The highlight of the evening was the greatly anticipated inaugural North West jiving competition. Taught by Galway East YFG's own Liam Coppinger, 10 couples with immense bravery took to to the dance floor and were adjudicated on by former YFG National Executive members and honorary life members of YFG, former Dáil deputy Madeleine Taylor-Quinn and Cllr. PJ Murphy. Our final victors on the night were Mayo's Antoinette Payton and Cavan/Monaghan's Paddy Mulligan, followed in second by Béibhinn Byrne from Wicklow and Galway East's Liam Coppinger, with UCC member Bébhinn



Lombard and Daniel Lynch from Galway East's Patrick Hogan Branch completing the top three. Our winners were again presented with a pot of honey provided by councillor Murphy. Over the course of the evening we were delighted to welcome members of the FG parliamentary party, notably Minister Martin Hendon and at the time Midlands North West Candidate, now MEP, Nina Carberry.

Whilst the North West social offered us an opportunity to rally our troops before the local and European elections, nothing could prepare us for the trojan effort put in by YFG across the North West and the country as a whole. In Connacht and Ulster, we had YFG candidates contesting for seats on Donegal County Council, Monaghan County Council, Galway County Council and Mayo County Council, whilst many YFG supporting councillors, contested seats on the local authorities as well. From the North Western perspective and given the division of the constituency, many of our members got to experience the campaign through Maria Walsh's campaign with our members out an about with her across the region, with memorable days canvassing and leafleting outside Connacht Football Championship and Rugby matches some of the highlights for our members.

Our election bonanza year was brought to a close with the General Election in November, where the North West again became a hive of activity for our members. Regional Canvas Days were ran by Mayo YFG for Minister Alan Dillon, Cavan Monaghan YFG for then Cllr. David Maxwell and University of Galway YFG for Minister Hildegard Naughton. Our National Campaign Day focused on Athenry and Galway East candidate Cllr. Clodagh Higgins. Our members also took every opportunity to get out with various other FG candies across the region and the country, with some going all the way and embarking a (and documenting) the Leader's Tour. Our members again got an even better taste of the political process with many taking part in the tallying of votes across the region a they had done for the locals and European, with their actions providing vital assistance in the areas of information gathering for future elections Whilst FG ultimately maintained its seat count across the North West and with the support YFG provided, we are well placed for gains in 2029.

#### **VP Report by Steven Murphy**

It has been a busy two years on the YFG National Executive. Particularly, as one of YFG's Executive Council representatives, it has been exceptionally busy as the party has navigated referendums, a local election, general election and change of Leader. Young Fine Gael has been a priority for me and my colleagues Eoghan and Béibhinn on the Executive Council where we used our voices to advocate for young candidates to be on as many Local Election ballot papers as possible. A large number of young candidates ran for Fine Gael in June and by my count we ended up with more 'YFG Councillors' than the Green Party has councillors in the whole country! As Director of Elections for YFG during the local elections, it was a privilege to liaise with so many young candidates and offer them as much support as we could as an organisation.

A personal highlight of my time as Vice-President is having had the opportunity not once but twice to present to the Fine Gael Parliamentary Party in Leinster House and I want to very kindly thank Deputies Richard Bruton and Alan Farrell for their invitations. The message was always positive as I believe that YFG is in a much better place now than when I first took office in early 2023. Our membership has increased significantly, bucking the trend of recent years. The elections provided ample opportunities for members to get together and the momentum of that is telling as there are so many candidates and contests at this conference. This is my eighth YFG National Conference and I can not ever remember so many candidates vying for a seat on the National Executive.

In our term plan for this Executive, we had three priorities: Attracting and retaining members; Contributing to the elections that would take place; and improving the health of our organisation. I believe that we have done ourselves proud in these areas and have made great strides in strengthening the organisation. While this conference is focused on providing a Blueprint for Action, I hope that our action facilitates an ever changing and growing organisation. The future is bright for YFG. Now is the time to capitalise on the progress we have made in recent years.

At the last YFG National Conference, I proposed many changes to our Constitution and Rules. The change I am most proud of is introducing a second Vice-President for YFG ensuring that there will be gender balance at the top table in YFG. In the past few years, I was also involved in setting up our 'Second-Level Network' to give younger members a chance to meet each other and discuss issues important to them. The more you put in, the more you get out and I have put my all into YFG over the past few years. I have learned so much about politics and about people and I hope that I have served you all well in my role as Vice-President. I want to thank my family, my girlfriend Erica and my many friends for all their help, support and patience in that time. It has been a privilege to have served on the National Executive of an organisation that has given me so much over the years and I want to wish the next National Executive all the best as they lead YFG into the future.

#### **Policy Report by Daniel Lynch**

The first item on the Policy Agenda this year was finalising the justice document: Building A Just Republic, which had begun under the term of the previous National Executive and was almost complete when I took office. I wish to particularly thank Eli Byrne, and my predecessor Kenneth Henry for the work they put into this document. This document set out a comprehensive list of justice reforms, from safeguarding and compensating victims of crime, to imposing tougher sentences on violent criminals, to increasing Garda Recruitment to make our communities safer. Our proposals were presented to the then Minister for Justice in July 2023 and an excellent conversation was had with Minister McEntee about how our proposals could be acted upon.

Budget 2024 saw the creation of our Pre-Budget Submission. This document was a bold departure from how previous documents had been written, as the membership had a greater contribution to this Pre-Budget Submission than any previous document. Thie first step in our membership consultation process was allowing branches to submit policy proposals to the National Executive to be included in the submission. I also organised an event in Leinster House where members came and split into smaller groups to discuss policy proposals. We then discussed all of those ideas together and those proposals all fed into the final submission that was presented to Minister Paschal Donoghue.

Shortly after Budget Season ended, YFG received a request from the Parliamentary Party to create a short, two page submission for the Select Committee on Local Government reform. A team was put together to create this submission including: Ciara Murphy, Eli, Byrne, and Art O'Mahony, and I'm very grateful to all of them for their hard work. The Select Committee recently published their findings before Christmas, and it was wonderful for Young Fine Gael to contribute to the Oireachtas Committee so productively.

Finally, last year saw the publication of two documents

in very quick succession: our Pre-Budget submission 'A Fair Deal', and our Youth Manifesto for the General Election 'The Way Forward.' Like the previous year, branch submissions were opened again, and an expanded policy session was held at the annual YFG Summer School. The key ask from Young Fine Gael in the General Election was for a clear commitment that the party would pass our Spiking Bill if re-elected to government. This ask was fulfilled in the Programme for Government which sets out a clear commitment to pass the bill during the term of this government.

#### YFG Women's Network Report by Béibhinn Byrne

Since our last National Conference, the YFG Women's Network has been busy with a range of initiatives. With only two women standing for election, increasing women's participation became a key priority for the outgoing National Executive. It has been a true privilege to collaborate with the remarkable Women's Network team throughout this term, watching new members find their footing and welcoming back those who have been involved for some time.

#### YFG Women's Network International Women's Day Event 2023:

The YFG Women's Network launched the new National Executive term with a social event at The Well on Stephen's Green. This gathering provided an opportunity for YFG women to connect, share their ambitions for the network, and discuss the importance of creating spaces where women can engage with the issues that matter most to them while also supporting one another.

#### Women of YFG Zoom Events:

The "Introduction to Serving on the YFG National Executive" session took place ahead of the first National Executive co-option in 2023. This event aimed to inform female members about the responsibilities of being on the National Executive and to encourage them to consider standing for election. The event was well-received, with former National Executive members sharing their experiences and offering advice.


"2024, Supporting Our Female Candidates" was organized

# Prickless Nights by Eoghan Gallagher

As people began to enjoy nights out again post COVID, a causal conversation amongst YFG members threw up the worrying rise in spiking instances in Ireland. It felt strange that there seemed to be little being done about it, and it was from there the Prickless Nights campaigned emerged.

In the latter stages of the previous national executive's term, led by then President Art O'Mahony, a lot of effort was put in to draft a Bill on spiking and to discuss the issue with stakeholders and the Parliamentary Party.

We picked up this work and after further discussion with the Fine Gael group of Senators, they agreed they would sponsor our Bill which sought to make spiking a standalone offence, and carry with it a maximum 10 year sentence. This we felt was an appropriate penalty for what is a despicable act. With the government making serious strides by making stalking and strangulation standalone offences, this was an obvious next step, and would give victims the confidence to report what happened to them.

Working closely with the Fine Gael senators, particularly Regina Doherty and Barry Ward, and with support of Simon Harris & Helen McEntee, the Bill successfully passed all stages in Seanad Éireann with cross party support.

The response to this campaign was overwhelming, and it really struck a chord with our generation. Many who have completely opposing views to FG or indeed do not follow politics at all were intent to approach us to share their harrowing story, or to thank us for championing the issue.

Media coverage was immense with many radio interviews completed, print media mentions, and even a shoutout on some popular podcasts.

Of course, legislation alone will not prevent this cruel act, and we ensured that we continued the two other components of the campaign - a call for a multi stakeholder awareness campaign, and for pubs & nightclubs to do more to tackle spiking on their premises. Many meetings with representative groups were held where a range of measures were discussed from training staff, equipping bouncers with equipment, making drink lids available, and much more.

Why anyone would ever spike another person is beyond comprehension, and is unfortunately something which is predominantly done to young females. Which so much to navigate in the modern world already, young people (and their families) deserve to be able to enjoy a night out without fear of being spiked.

With the 'Non-Fatal Offences against the Person (Amendment) (Spiking) Bill 2023' now needing to be brought forward in the Dáil, early stage conversations have been held with our new Fine Gael TDs about sponsoring the Bill. We were delighted that thanks to our lobbying, a commitment to the measures was contained in the Fine Gael manifesto and the subsequent Programme for Government. The onus now falls on the incoming National Executive to pursue this further, and ensure that this Bill is enacted onto the Irish Statue book.

To have a Bill pass all stages of the Seanad is an enormous achievement. No other youth organisation, yet alone youth political party, have achieved this before. We should be very proud of every member to played their part in ensuring this happened.

It is, in my view, up there alongside the illegitimacy campaign of the 1980s as one of our YFG's greatest achievements, and something which will be spoken of for decades to come

# International Committee Report 2023/2025 by Shane Price

The IC has represented YFG with delegates at all Youth of the European People's Party (YEPP) Council meetings since the term of this IC began in May 2023.

The first event was the YEPP Congress 2023 which took place in Braga, Portugal and elected the 2023/25 board in June 2023. A large success for YFG was of our member Eoin Scarlett, who topped the poll for Vice-President. Eoin's election to this prominent position was a testament to the respect and influence YFG holds within the wider European youth political community. His success is a direct reflection of YFG's dedication to engaging in key international political processes and providing our members with opportunities for leadership on a global scale.

YFG regularly attends YEPP council meetings, which are are three-day conferences held every three to four months, and consist of two delegates from every YEPP member party, a number of invited guests from partner parties, the YEPP board, and additional members of the local host party. They are hosted by different member parties throughout Europe. YFG has sent delegates and attended regular YEPP Council meetings in including council meetings in Brno, Czech Republic, Skopje, North Macedonia, Turin Italy, Athens Greece and Rabat Morocco

The international committee has been active in fostering collaboration with our sister pirates across Europe. The IC held a two zoom calls with our Spanish Slster Party NNGG to discuss the outcomes of the Spanish General election and also held discussions with our Lebanese sister party, Youth Forces Ketab.In May 2023 YFG hosted a delegation of KAS and JU students who were visiting Ireland on a scholarship and YFG sent delegates to various sister partiy confrences, such as KNL's Conference in Flnland, CJDA's conference in the Netherlands, and the JU's annual Deutschlandtag in Germany.

In terms of policy work, YFG passed a significant policy calling for an immediate ceasefire in Gaza, reflecting our commitment to human rights, peace, and stability in the region. This policy demonstrates YFG's ability to take a firm stance on important international issues, advocating for a resolution to conflict in a way that aligns with our core values

In addition, we also adopted a policy calling for the advancement of a trade agreement between the European Union and Australia. Recognising the importance of building strong economic partnerships in a rapidly changing global landscape, YFG advocated for closer ties between the EU and Australia to promote trade, innovation, and cooperation on shared global challenge and most recently called on the new government to asses a policy towards independence for Somililand

The International Committee was primarily active in preparing for the European Elections in May 2024. We launched this policy document in March 2024 with Colm Brophy TD in Leinster House. This comprehensive document outlines our priorities on key European issues, from climate action and economic growth to digital innovation and social inclusion. The launch of this document was an essential part of our campaign to ensure that YFG's values are reflected in the future direction of the European Union, and it was a key tool in engaging with European stakeholders and ensuring our influence on the electoral process. The International committee also met with Jennifer Carroll MacNeil in government buildings to discuss and advocating for the priorities outlined in the EU Manifesto.

This past term has been a period of remarkable growth and achievement for Young Fine Gael on the international stage. From representing our interests at YEPP Councils to shaping key policy positions, YFG has been an active and influential voice in European and global discussions. As we move forward into 2025 and beyond, I am confident that YFG will continue to build on this momentum, ensuring that our organisation remains a strong advocate for youth leadership, European integration, and international cooperation.

# **Constitution & Rules**

(Bunreacht & Rialacha)

#### **Young Fine Gael**

As amended after the 32nd YFG National Conference (February 2023)

Young Fine Gael, the Young United Irelanders is an Irish Nationalist Youth Movement that pledges allegiance and fidelity to Ireland and derives its inspiration and endeavour from this bedrock. Young Fine Gael is an autonomous yet integral part of the Fine Gael party; it seeks to advance the political representation and objectives of the youth of Ireland through the vehicle of the Fine Gael Party. Young Fine Gael is wholly committed to the development of young people at all levels of political life, and in communion with the Fine Gael Party seeks to maximise the electoral objectives of Fine Gael.

#### 1. Name

- 1.1 The name of the Organisation shall be Young Fine Gael (The Young United Irelanders), or in Irish shall be Ógra Fhine Gael (Na Gaeil Aontaithe Óga) and referred to the Organisation in this Constitution, shall be deemed to be an organ of Fine Gael.
- 1.2 The Organisation shall foster, promote and develop an interest among young people in political activity and shall seek to promote young candidates in Fine Gael.
- 1.3 The Organisation shall formulate policy representative of the membership of Young Fine Gael.
- 1.4 The Organisation shall take all possible measures to achieve the implementation of all such policies.
- 1.5 The Organisation shall work for the electoral success of Fine Gael.

#### 2. Units And Organs Of The Organisation

- 2.1 The Units of the Organisation shall be:
- (a) The Branch (An Cumann)
- (b) The Regional Councils (Na Comhairlí Réigiúnacha)
- 2.2 The organs of the Organisation shall be:
- (a) The Young Fine Gael National Executive (Ardchoiste Ógra Fhine Gael)
- (b) The National Conference Steering Committee (Coiste Stiúrtha na Comhdhála Náisiúnta)
  - 2.3 A II elections to office within the Organisation shall be carried out by the proportional representation single transferable vote system (PR-STV).
  - 2.4 (a) At least three days notice in writing of any meeting of any unit of the Organisation shall be

- given to all members of that unit plus the Constituency Youth Officer and the National Youth Officer.
- b) ( At least six days notice in writing of any meeting of the National Executive shall be given to all Secretaries
- of the Organisations branches, save where the National Executive deems the nature of the meeting to be of particular confidentiality or urgency in nature.
- (c) N otice must detail an exact date, time and venue for the meeting of that unit.
- (d) If a meeting is being held in a virtual space, notice must detail an exact date, time and link to join the meeting of that unit.
- (e) If a meeting is being held in a hybrid manner, notice must detail an exact date, time, venue and link to join the meeting of that unit.
  - 2.5 Except where specified in this Constitution where for any reason an officer vacates office such office shall be filled by election from amongst and by the members concerned.
  - 2.6 A person may not hold the same office within the Organisation, for more than consecutive three terms. Terms are still considered to be consecutive if they are co-opted at a date after National Conference.
  - 2.7 The quorum for a Branch meeting shall be five; for branches with a membership of over thirty the quorum shall be eight.
  - 2.8 Units may draw up Standing Orders to govern their proceedings provided such Standing Orders do not contradict any provision of this Constitution and provided that such Standing



Orders are accepted by the National Executive and passed at the Annual General Meeting, or a meeting called for that purpose, of the unit concerned and notified in writing to all members of the unit.

- 2.9 An Officer of any unit who, during his term of office, absents himself from three consecutive meetings of that Unit without furnishing the Chairperson or Secretary of that Unit with a written explanation acceptable to that Unit will be subject to a vote of confidence at the next meeting.
- 2.10 N o member of the organisation may be elected an officer of any unit or organ of the organisation in absentia.

#### 3. Membership

- 3.1 The means by which a person attains membership are as follows:
- (a) Membership of a Branch of where they are ordinarily resident, Or
- (b) Where no functional branch exists, a person may be affiliated to their nearest local branch.

And/or

- (c) Any member attending a third-level college shall have the right to join that college branch.
- (d) At the discretion of the National Executive of Young Fine Gael a member may join a branch in a district/ constituency where they are not normally resident on written application to and agreement from the National Executive of YFG only in the circumstance whereby a functional branch exists in their place of normal residency.
  - 3.2 N o person shall be a member of the Organisation before the age of 15 and shall not be eligible to renew membership beyond the age of 35.
  - 3.3 (a) Any member of the Organisation may not be a member of any other political organisation
  - (b) Only members of the Organisation may hold office within the Organisation.
  - 3.4 B y accepting membership of the Organisation, each member agrees to be bound by and shall submit to the rules and by-laws of the Organisation.
  - 3.5 The National Executive may, at any time, refer any member of the Organisation to the Fine Gael Executive Council for any breach of this Constitution and Rules, or for any actions which,

in its consideration, have damaged the interests of the Organisation.

#### 4. The Branch

- 4.1 The basic unit of the organisation shall be the Branch. Each Branch shall consist of not less than eight members.
- 4.2 E ach Branch shall be affiliated to Fine Gael as provided for in Part II of the Fine Gael Constitution.
- 4.3 The National Executive may establish local branches whose functional area shall comprise of more than one Dáil constituency.
- •A branch established in this manner shall have the same status as any other branch of the organisation and members of this branch shall have the same status as any other local member of the organisation.
- Members of a branch established in this manner should have voting rights for the purposes of constituency
  - executive meetings and selection convention in one and only one constituency and this shall be the constituency in which the member is resident in.
- This provision shall be in government and implemented in accordance with the provisions of the Fine Gael Constitution and Rules.
  - 4.4 The Officers of the Branch shall consist of a Chairperson (Cathaoirleach), a Vice-Chairperson (Leaschathaoirleach), a Secretary (Rúnaí), two Treasurers (beirt Chisteoirí), a Public Relations Officer (Oifigeach Caidrimh Phoiblí) and an Inclusion Officer (Oifigeach Ionchuimsitheach). The Branch Chairperson shall act as the second treasurer. The Branch may elect other officers if it so desires.
    - 4.5 A member may not hold the position of Chairperson in more than one unit of the organisation without the approval of the National Executive. Approval may only be granted exceptional circumstances and for a set period of time.
    - 4.6 Branches shall be required to furnish particulars to the National Executive on request.
    - 4.7 Approval for the establishment of a Young Fine Gael Branch is at the discretion of the Young Fine Gael National Executive.
    - 4.8 In order to establish a local branch of Young Fine Gael an official launch must be held, written notice of a launch must be furnished to the National Executive and the National Youth Officer at least 21 days in advance of the proposed launch date.

# Blueprint for Action

- 4.9 Fourteen days written notice of any branch launch must be furnished to all elected Fine Gael representatives in that Dáil Constituency, the Fine Gael Constituency executive for that Dáil Constituency to also include the Youth Officer appointed for that Dáil Constituency and to the National Executive of Young Fine Gael and to the National Youth Officer.
- 4.10 In the case whereby a previously established Young Fine Gael branch, which has lapsed in its affiliation for a minimum of one year the above procedure (articles 4.7 to 4.9) must be followed in order to re-establish the branch as a functioning unit of the Organisation.
- 4.11 A branch may run a local campaign in their area or campaign for official policy of the Organisation, provided that the campaign is not contradictory to official policy and that the relevant Regional Organiser is informed not less than seven days before any campaign commences.
- 4.12 B ranches must furnish their Regional Organiser and the National Youth Officer a copy of an agreed programme of activity for the 12 months ahead within 1 month of the holding of an AGM.

#### 5. National Executive (An Tardchoiste)

- 5.1 Subject to the authority of the National Conference the management, control, government and administration of the Organisation shall be vested in and exercised by the National Executive.
- 5.2 The National Executive shall consist of:
- a) A President (An tUachtarán), who shall be the Leader of the Organisation, chair of the National Executive and shall be the nominee for the Organisation's first seat on the Fine Gael Executive Council.
- b) Two Vice-Presidents (na Leasuachtarán), one who shall be male and one who shall be female, and who shall be the nominees for the Organisation's second and third seats on the Fine Gael Executive Council.
- c) Eight ordinary members of the National Executive elected at the National Conference in the manner prescribed in Section 6.11.
- d) The President shall be required to co-opt a maximum of three additional members to the YFG National Executive, ensuring as a constitutional requirement that a minimum of 30% of the YFG National Executive are female and a minimum of 30% of the YFG National Executive are male at all times.
  - 5.3 The National Executive shall take office at the close of the National Conference and leave office

- at the close of the following National Conference.
- 5.4 The National Executive may adopt Standing Orders from time to time to govern the conduct of its meetings and its day-to-day operations.
- 5.5 M embers of the former National Executive must provide a handover document to their counterpart on the new National Executive within a month of National Conference to provide information, advice and guidance.
- 5.6 The National Executive shall meet at least ten times per year.
- 5.7 The President shall assign portfolios and responsibilities to the members of the National Executive. He shall have the authority to change these portfolios at his discretion. The President must appoint a National Secretary when assigning portfolios.
- 5.8 The National Executive shall produce a report to be presented to the National Conference
- 5.9 A ll members of the National Executive as elected at the National Conference shall work as a unit to furnish all members with, within 45 days of the National Conference, a proposed programme of activity for the coming term of the Executive. The National Executive must furnish all members with an update of this programme of activity no more than 6 months after the programme of activity was initially shared with the membership. Updates shall be given every subsequent 6 months within the term of the National Executive of which the programme of activity belongs.
- 5.10 N o person shall remain a member of the National Executive in the same capacity for more than three terms.
- 5.11 N o person shall remain a member of the National Executive for longer than four terms.
- 5.12 In the event of the President failing to serve his full term of office, the position will be assumed by the Vice-President. The vacancy for the position of VicePresident shall accordingly be filled by appointment of the President, in consultation with the National Executive.
- 5.13 In the event of a Vice-President failing to serve their full term of office, the vacancy shall be filled by the member of National Panel who received the highest vote at the National Conference.
- 5.14 In the event of any other officer failing to serve his full term of office, the vacancy shall be filled



- by appointment of the President, in consultation with the National Executive. In such circumstances the branches from the electoral region where the vacancy arises may submit names for consideration. The appointee must be a member of a branch in the region concerned.
- 5.15 A National Youth Officer, who shall be employed by Fine Gael, in consultation with the President and the National

Executive, shall act as a Cabinet Secretary to the National Executive and shall be required unless reasons are given 5 working days in advance to the President and General Secretary of the Party, to attend all meetings of the National Executive.

- 5.16 The National Youth Officer shall present a membership affiliation report at each meeting of the National Executive.
- 5.17 The members of the National Executive and the National Youth Officer may attend any meeting of any unit or organ of the Organisation.
- 5.18 The National Executive may appoint subcommittees as deemed necessary and shall
  determine the power and duration of such subcommittees. Save with the express consent of
  the National Executive, any member of the
  National Executive who is a member of any such
  sub-committee will be deemed to have resigned
  from that sub-committee on ceasing to be
  member of the National Executive.
- 5.19 A Women's Network Committee, a Coiste na Gaeilge and a Second Level Network shall be established at the start of each Executive term in accordance with Article 5.17 of this Constitution. The President in agreement with the National Executive shall nominate a member of the National Executive to act as liaison to the Network.
- 5.20 A ny member of the National Executive who, during his term of office, absents himself from three meetings of that body without furnishing an acceptable written explanation will be deemed to have resigned their position.
- 5.21 O fficers or units of the organisation wishing to select or appoint members to officially represent the organisation at external events must obtain the approval of the National Executive before making the appointment. Notification for the request for nomination to external bodies must be furnished to all branch chairpersons who

in turn if desired may make recommendations to the National Executive who will appoint the nominee to be sent forward.

- 5.22 The President in agreement with the National Executive shall appoint an International Secretary and Deputy International Secretary who from time to time will represent the organisation abroad. Neither the International Secretary nor Deputy International Secretary have to be members of the National Executive.
- 5.23 R egional Organisers in agreement with the National Executive may call an EGM of any branch in their region if deemed necessary.

#### 6. National Conference (An Chomhdháil Náisiúnta)

- 6.1 The National Conference shall be the supreme authority of the Organisation.
- 6.2 The National Conference shall be held once in every 18 months on a date set by the National Executive unless specifically opposed by the Fine Gael Executive Council with the National Executive elected on every occasion.
- 6.3 E very member of the Organisation who attained membership as prescribed in Article 3.1 no later than 31 October preceding the National Conference shall be entitled to one vote at the National Conference subject to the presentation of photo ID.
- 6.4 The National Conference Steering Committee shall draw up the agenda for the National Conference.
- 6.5 The President of Young Fine Gael, the two Vice Presidents and the ordinary members of the National Executive shall be elected at every National Conference.
- 6.6 A Il candidates for election to the National Executive shall be proposed and seconded by not less than two Branches in the constituency in which they are a candidate. All nominations shall be submitted to the National Conference Steering Committee from at least twenty-one days before the commencement of the National Conference. For a national constituency a candidate requires a nomination from at least 2 branches in at least 2 regions as defined by Article 6.11 (a).
- 6.7 There shall be at least sixty days written notice of the National Conference to all members of the Organisation.
- 6.8 A II elections at the National Conference shall be carried out using the Seanad Electoral system. The General Secretary of the Fine Gael Party or his Nominee shall act as returning officer.
- 6.9 In the election of President all members of the Organisation are entitled to one vote.
- 6.10 In the election of Vice-President all members of the Organisation shall be entitled to one vote.
- 6.11 The ordinary members of the National Executive shall be elected as follows:

# Blueprint for Action

- (a) One ordinary member of the National Executive of Young Fine Gael shall be elected from each of the following regions:
  - I. The province of Leinster (excluding Dublin)
  - II. The county of Dublin
  - III. The province of Munster
  - IV. The provinces of Connacht and Ulster. The persons elected shall act as Regional Organiser for the region from which they are elected.
- (b) Four ordinary members of the National Executive of Young Fine Gael shall be elected from a National Constituency, as in the manner of the Presidential Executive Council Representative Elections.
- (c) A II members entitled to vote in a constituency, in accordance with Article 6.3 of this constitution, are entitled to contest an election in that constituency.
  - 6.12 M otions and Resolutions for the National Conference, and amendments to the Constitution, may be put forward by the National Executive and units and organs of the Organisation not less than twenty-one days before the date of commencement of the National Conference.
  - 6.13 The National Flag of Ireland and the flag of the European Union will be displayed at the National Conference.
  - 6.14 A mhrán na bhFiann shall be played to signify the start and the end of the National Conference.

# 7. The National Conference Steering Committee (Coiste Stiúrtha Na Comhdhála Náisiúnta)

- 7.1 The National Conference Steering Committee shall be appointed by the National Executive and shall consist of not less than five and not more than eight persons and shall be comprised of:-
- (a) The President and Vice-President (if not seeking reelection)
- (b) Members of the outgoing National Executive (not seeking reelection), such that

the total number of members of the National Executive shall be at least four

(c) N ot more than four other members of Young Fine Gael or Fine Gael who possess particular skills or experience which would be essential to the arrangement of the logistics of the National Conference, or who are members of Fine Gael in the constituency where the National Conference is taking place.

The National Youth Officer shall be an ex-officio member of the National Steering Committee. The National Executive shall appoint a Chair of the National Conference Steering Committee, who shall not be a member of the

- outgoing National Executive, and issue Standing Orders to it upon its appointment which shall govern its operations.
- 7.2 The functions of the Steering Committee shall be:
- (a) to organise the logistics of the National Conference,
- (b) to draw up Standing Orders for the National Conference,
- (c) to select the motions for discussion at the National

  Conference, noting any direction from the National

  Executive regarding the compilation and adoption of the organisation's Policy Manifesto.
- (d) to ensure that all proceedings are ethically conducted and in accordance with the Constitution and Rules of the Organisation,
- (e) to draw up the agenda for the National Conference.
- (f) to organise a minimum of four Regional Hustings to take place no more than 21 days before the National Conference noting any direction from the Regional Councils.
- 7.3 No candidate may be a member, at any stage, of the Steering Committee for the National Conference at which he is a candidate.

#### 8. Policy

- 8.1 The sole responsibility for the co-ordination of policy creation within the organisation lies with the National Executive, which may, from time to time, ratify a policy manifesto or refer same to a National Assembly. Any such manifesto shall be subject to Article 6.1 of this constitution.
- 8.2 O fficial policy of the Organisation is that which has been approved by the National Executive or National Conference or (if referred to it by the National Executive) the National Assembly.
- 8.3 The National Executive may establish Policy committees, provided that sufficient interest exists among members, membership of which shall be open to all members of the organisation. The National Executive shall determine the scope, nature, duration and terms of reference of such committees.
- 8.4 The National Executive must hold a policy think-in for members to contribute to Young Fine Gael policy formation. Any policy proposals are subject to Article 8.2 of this constitution.
- 8.5 The W.T. Cosgrave Excellence in Policy Award shall be presented to the best contribution to policy by a branch or individual member that year. The winner shall be decided by the National Executive and the award shall be presented each year at Summer School.

#### 9. National Assembly (An Tionól Náisiúnta)

- 9.1 The National Assembly shall consist of a delegation from each affiliated Young Fine Gael branch. These delegations shall consist of the Branch Chairperson, or where unable to attend, the Branch Vice-Chairperson, and two other delegates chosen by the branch to attend.
- 9.2 The National Assembly shall meet at least once a year to be held at the Organisation's Annual Summer School or shall be held at the request of the President or where sixty per-cent of the National Executive or more agree that a National Assembly be held. Should two-thirds of affiliated Young Fine Gael branches petition the National Youth Officer, a National Assembly must then be held within six weeks of the petition reaching the required level of support.
- 9.3 The National Executive shall inform all members of the Organisation of the National Assembly twenty-one days in advance.
- 9.4 These meetings of the National Assembly must be presided over by the President or the Vice-President in his absence. All members of the National Executive shall attend meetings of the National Assembly.
- 9.5 Each member attending the National Assembly must be provided with a list of dates of National Executive meetings since the last National Assembly meeting or Young Fine Gael National Conference, whichever being the latter or the two to have taken place and attendance records at these meetings must be presented by the Young Fine Gael National Secretary to the National Assembly.
- 9.6 The functions of the National Assembly shall be to allow members the opportunity to raise issues with and ask questions of members of the National Executive. The Organisation's three representatives on the Fine Gael Executive Council shall provide a report to the membership on their activities as members of that body at the National Assembly. Branches may submit written questions or issues to be addressed up to a week in advance of National Assembly, however questions or issues which have not been previously submitted may still be raised on the floor of the National Assembly.
- 9.7 The National Assembly may dismiss any member of the National Executive by a vote of 75% or more, provided that a motion of dismissal has been sent to the National Youth Officer by at least five Branches and a Regional Council of the Organisation at least 14 days before the meeting. It then must be included in the agenda for the meeting.

#### 10. Regional Council (An Chomhairle Réigiúnach)

- 10.1 The National Executive shall establish Regional Councils.
- 10.2 The National Executive shall determine the geographical scope, nature, duration and terms of reference of each Regional Council.
- 10.3 The President, in consultation with the National Executive, shall appoint one member of the National Executive to each established Regional Council. The appointed member shall act as a Cabinet Secretary to the Regional Council. They may be deputized by another member of the National Executive.
- 10.4 The tasks of the Regional Council shall be:
- (a) To develop and co-ordinate the organisation in that region.
- (b) To provide an opportunity to discuss mutual needs between branches.
- (c) To co-ordinate regional campaigns in conjunction with the National Executive of the organisation.
- (d) To foster and promote close cooperation with units of units and organs of the Fine Gael Party.
- (e) To discuss resolutions proposed by the council to the branches.
  - 10.5 N o member shall be eligible to serve on two Regional Councils at the same time.
  - 10.6 E ach Regional Council will have a Regional Inclusion Officer who will coordinate with the Branch Inclusion Officers in their region and work with the National Youth Officer and Members of the National Executive.

# 11. Fine Gael Constituency Youth Officers (Oifigigh Óg Dháilcheantar Fhine Gael)

- 11.1 There shall be a Constituency Youth Officer for each Dáil Constituency or where a Dáil Constituency consists of two or more counties, there may be a Constituency Youth Officer for each county.
- 11.2 The role of the Constituency Youth Officer shall be:
- To promote the development of the Organisation and the recruitment of youth members within the constituency.
- •To represent the Organisation at all meetings of Fine Gael Constituency Executive & Constituency Officer Board.
- To foster the full participation of the Organisation in Constituency Activities especially at times of elections.
  - The National Executive shall request a report from each Constituency Youth Officer on their work once in each calendar year. Any Constituency Youth Officer who fails to submit such a report within three months of it being requested shall be deemed to have vacated the position,



- with a replacement to be selected in accordance with the processes outlined in this Article.
- 11.3 The Constituency Youth Officer shall be elected at the Annual General Meeting of the Fine Gael Constituency Executive. In the election, all members of the Organisation shall have one vote and only members of the Organisation may vote.
- 11.4 I f, between Annual General Meetings of the Fine Gael Constituency Executive the position of Constituency Youth Officer is vacant, then the Regional Organiser shall convene a special meeting of the Organisation in the constituency to elect on a replacement Constituency Youth Officer to serve until the next Annual General Meeting of the Constituency Executive. A week's written notice of such a meeting must be given to all members of the Organisation within the constituency, Constituency Executive, the Regional Council, the National Youth Officer, and the National Executive.
- 11.5 W here no Branch of the Organisation exists in a constituency and where no Constituency Youth Officer has been approved, the President, in consultation with the National Executive shall appoint a Constituency Youth Officer for that constituency.
- 12. Alteration And Interpretation
- 12.1 A ny provision of this Constitution may be amended, whether by way of variation, addition or repeal, only by a two-thirds majority of a quorate session of the National Conference.
- 12.2 T his Constitution and Rules, as amended, shall be communicated by the President to all members of the Organisation within thirty-five days of the close of each National Conference. It shall also be posted to the organisation's website.
- 12.3 In this Constitution, where the context so admits and unless the contrary intention appears words singular shall include the plural and words in the plural shall include the singular. Words denoting the female gender shall include the male gender and vice versa.
- 12.4 In the event of a conflict over the interpretation of this Constitution or the validity of organisational procedures, the first body of appeal shall be the National Executive, and the final body of appeal shall be the Executive Council of Fine Gael.
- 12.5 The Constitution shall come into effect immediately on being approved by the National Conference. The Constitution of Young Fine Gael in force immediately prior to the coming into operation of this Constitution shall, of that date, cease to have any effect.
- 12.6 This Constitution shall be subject to the overriding

- of any conflict, the provision of that Constitution shall prevail. In the event that no provision exists in this Constitution for a particular situation, but provision does exist in the Fine Gael Constitution, then the provision of that Constitution shall apply.
- 12.7 The National Executive and the National Assembly shall ensure that all provisions of the Young Fine Gael Constitution and the Constitution of Fine Gael are upheld.

# Constitutional Amendments

### 1. Unit Term Limits

In Article 2.6, DELETE the word "three" and SUBSTITUTE with the word "five."

ADD the words "unless otherwise specified in this constitution" at end of the first sentence.

**Effect:** This brings (Branch/Regional Council) term limits in line with the Fine Gael constitution, whilst keeping rules about National Executive term limits in its current form.

Proposed by: Wexford YFG

### 2. Membership Age (I)

In Article 3.2, DELETE the number "35" and SUBSTITUTE with "30"

**Effect:** Reduces the membership upper age limit to 30 years of age. (Note: Amendment 3 falls if this amendment is passed)

Proposed by: Wexford YFG

### 3. Membership Age (II)

In Article 3.2, DELETE the number "35" and SUBSTITUTE with "40"

**Effect:** Increases the membership upper age limit to 40 years of age. (Note: This amendment falls if Amendment 2 is passed)

Proposed by: Wexford YFG

### 4. Multiple Units (I)

**DELETE Article 4.5** 

**Effect:** A member may be chair of multiple units. (Note: Amendment 5 falls if this amendment is passed)

Proposed by: Wexford YFG

### 5. Multiple Units (II)

In Article 4.5, DELETE the words "for a set period of time" and SUBSTITUTE with "may only last a maximum of three months"

**Effect:** A member may be chair of multiple units for no more than three months, with the express permission of the National Executive.

(Note: This amendment falls if Amendment 4 is passed)

Proposed by: Dublin West YFG

### 6. Programme of Activity

DELETE Article 4.12

**Effect:** Removes the need for a branch to submit an agreed programme of activity to the Regional Organiser and National Youth Officer.

Proposed by: Wexford YFG

### 7. Location of National Executive Meetings

In Article 5.6, INSERT the sentence "At least one meeting must be held in each of the four regional council areas" at the end of this article.

**Effect:** Requires that National Executive to have at least one meeting in Dublin, at least one meeting in Leinster, at least one meeting in Munster, and at least one meeting in the North-West as part of its ten meetings in one year.

Proposed by: Dublin West YFG

### 8. Vacancy for President

DELETE wording in Article 5.12 and SUBSTITUTE with "In the event of the President failing to serve their full term of office, the National Executive shall decide via secret ballot, which Vice-President will assume the role of President. The vacancy for the position of Vice-President shall accordingly be filled by appointment of the President, in consultation with the National Executive, in accordance with Article 5.2 (b)."

**Effect:** Clarifies the process for the National Executive to elect a new President should a vacancy ever arise – as well as providing clarity on how a new Vice-President should be appointed in the aftermath of such an election.

Proposed by: Clare YFG

### 9. Vacancy for Vice President

DELETE wording in Article 5.13 and SUBSTITUTE with "In the event of a Vice President failing to serve their full term of office, the vacancy shall be filled by the member of National Panel who received the highest vote at the National Conference in accordance with Article 5.2 (b). If not, the appointment of a new Vice President shall be made by the President in consultation with the National Executive."

**Effect:** Clarifies the process for the election of a new Vice-President and safeguards the ability to appoint a new

Vice President in instances where the gender requirement cannot be filled from the membership of the National Executive.

Proposed by: - Dublin West YFG & Patrick Hogan (Galway East) YFG

### 10. Renumeration

In Article 5.19, SUBSTITUTE "5.18" in place of "5.17"

**Effect:** Corrects a renumeration error from a previous National Conference.

Proposed by: Wexford YFG

### 11. Prevention of (International Committee Secretarial) Dual Mandates

In Article 5.22, SUBSTITUTE the words "may not occupy" in place of "have to."

**Effect:** Clarifies that members of National Executive members may occupy the positions of International Secretary or Deputy International Secretary.

Proposed by: Wexford YFG

### 12. Term Limits of International Committee Secretarial Positions

At the end of Article 5.22, ADD the sentence "A member may only occupy these roles for a maximum of three terms"

**Effect:** Installs a term limit of no more than three terms for the positions of International Secretary and Deputy International Secretary.

Proposed by: Dublin West YFG

### 13. National Executive Candidate Thresholds

In Article 6.6, SUBSTITUTE the words "at least one branch from each of the four regions" in place of "at least 2 branches in at least 2 regions."

**Effect:** Reduces threshold for a candidate to contest certain National Executive positions.

Proposed by: Dublin West YFG

# 14. Matters Arising from Two Vice Presidents (I)

In Article 7.1 (a), SUBSTITUTE the words "and both Vice Presidents" in place of "and Vice President"

**Effect:** Updates the Constitution in light of previous

amendments regarding the introduction of a female Vice President at the 31st Conference.

Proposed by: Patrick Hogan (Galway East) YFG & Clare YFG

### 15. Eligibility for WT Cosgrave Award

In Article 8.5, INSERT the words 'or network' after the word 'branch'.

**Effect:** Enables Networks to be rewarded the Cosgrave Award

Proposed by: YFG Womens Network & Dublin West YFG

### 16. Information of Motions Passed at Conference

INSERT a new Article 8.6 which reads: "All motions and resolutions passed at the National Conference shall be compiled and sent to members within thirty-five days of the close of conference and shall be posted to the organisation's website"

**Effect:** Applies similar rules to that of the senior party's practices.

Proposed by: Wexford YFG

### 17. National Assemblies

In Article 9.2, SUBSTITUTE the words "twice a year; once at the Organisation's Annual Summer School, with another to be held at a different National Event" in place of "once a year to be held at the Organisation's Annual Summer School"

**Effect:** Increases the minimum number of National Assemblies to be held per year.

Proposed by: Louth YFG

### 18. Threshold to call a National Assembly

In Article 9.2, SUBSTITUTE the word "half" in place of "two-thirds"

**Effect:** Reduces the amount of branches needed to call a national assembly.

Proposed by: Wexford YFG

# 19. Matters Arising from Two Vice Presidents (II)

In Article 9.4, REPLACE all the words with the following: "These meetings of the National Assembly must be

presided over by the President or one Vice-President, designated by the President, in his absence. All members of the National Executive shall attend meetings of the National Assembly."

**Effect:** Updates the Constitution in light of previous amendments regarding the introduction of a female Vice President at the 31st Conference.

Proposed by: Patrick Hogan (Galway East) YFG

### 20. Youth Officer Reports

In Article 11.2 DELETE the words: "The National Executive shall request a report from each Constituency Youth Officer on their work once in each calendar year. Any Constituency Youth Officer who fails to submit such a report within three months of it being requested shall be deemed to have vacated the position, with a replacement to be selected in accordance with the processes outlined in this Article"

**Effect:** Removes the requirement for the Youth Officer to submit a report to the National Executive – and all punitive measures for failure to submit same.

Proposed by: Wexford YFG

### 21. Voting on Amendments

In Article 12.1, DELETE the words "two-thirds"

**Effect:** Allows for the constitution to be amended by a simple majority vote rather than a two-thirds majority.

Over the course of the conference, or at any stage throughout the year. I am always an email or a phone call away. I hope you have a wonderful weekend and a constructive National Conference.


















































